## Weekly DuPage County COVID-19 Metrics for Schools



## Rose

This week we DuPage County has moved to the substantial level of transmission. This is due to the metric for the number of cases per 100,00 people. In Roselle, our newest cases were in the adult age range. Important Note: The metrics are always for the week prior to posting. For now, we are continuing with in-person instruction. We will continue to monitor closely, and we will continue to speak with the DuPage County Health Department twice weekly.

At the end of eight weeks of school, we have had 4 cases of COVID-19.

## **Outside Activities**

As we see numbers increase in the Chicago area and neighboring states, we need all families to be very vigilant about their activities away from school. If your family is choosing to travel (even by car) and/or engage in activities with people outside of your household, particularly when it involves close contact, we ask that you discuss exposure of others to COVID-19 and quarantine your students for 14 days when you are traveling and/or participating in things such as tournaments where you are exposed to many people outside of your household members, are in close contact in locker rooms, etc. Whether or not people are in masks, being a close contact to others puts you at risk and therefore increases the risk for our staff and other families. All of the families who chose in-person instruction are relying on each other to be cautious and err on the side of caution. Our staff are coming to work each day trusting our D12 families to also prioritize the health and safety of them and their families.

We will begin discussions with the Board of Education at Tuesday's meeting about how we will plan for Thanksgiving and Winter Break when families may be more likely to see extended family.

I know that as the months drag on, the realities of life in a pandemic wear on everyone. As a hockey mom for fifteen years with my children, I know the positive impact of sports as well as the many activities and traditions families participate annually with Halloween and the approaching holidays. If you determine that participation in sports or other activities that put your child in close contact with others is the right choice for your family, we ask that you take the additional steps of keeping others safe by quarantining your children. In the cases we have had with students in our district, they have been primarily asymptomatic or a stuffy nose being the only symptom present. This is not always the case with adults who come into contact with asymptomatic cases, and we need to protect everyone who is in our schools.
