

E-learning Plan for Weather or Other Emergencies

In 2019, prior to the pandemic, the District submitted an e-learning plan to the state for approval. This would allow the District to use e-learning (also called remote learning) for emergency school closures instead of using an emergency day. At the time, districts around the state were doing the same yet we had no idea of what e-learning would look like. Six months later, we learned very quickly with the onset of the pandemic. Our criteria stated that if we anticipated a weather event would cause schools to

close and teachers had the opportunity to have materials ready and Chromebooks went home with all students, we would have an e-learning day. If it was an unanticipated event, we would have a traditional school closure day. Since 2019, we have had one e-learning day for weather and one traditional school closure day.

Now that we are through the pandemic and well past the days of students engaged in remote learning, it is time to renew our e-learning plan. After speaking with some of our kindergarten team as well as parents on our District Parent Advisory Committee, we do not feel that there is a benefit to having e-learning days for emergency closures. Our students are no longer accustomed to logging in from home, accessing their teachers' landing pages, and navigating through the Google meetings. Additionally, parents are no longer accustomed to this type of learning. We believe that the best course of action is to have traditional school closure days and make them up during the five days at the end of our calendar reserved for emergency days.
