### TRUTH IN TAXATION LAW RESOLUTION

**NOW, THEREFORE,** Be It Resolved by the Board of Education of Roselle School District 12, DuPage County, Illinois, as follows:

<u>Section 1: That</u> the Board hereby determines that the proposed aggregate levy, exclusive of election costs and levies for debt services and certain leases, estimated to be necessary to be raised by taxation for the year 2022 upon the taxable property in the District is \$10,681,587.

<u>Section 2: That</u> the amount of property taxes, exclusive of election costs and levies for debt service and certain leases, extended on behalf of the District for the year 2021 was \$9,936,542.83.

<u>Section 3: That</u> the foregoing proposed estimated aggregate levy for the year 2022 is equal to 7.5 percent of the foregoing taxes extended for the preceding year, 2021.

Section 4: That the Secretary of the Board is hereby authorized and directed to publish or cause to be published a legal notice of public hearing, in the form of **EXHIBIT** A attached hereto, in accordance with the requirements of the Truth in Taxation Law.

Section 5: This Resolution shall be in full force and effect upon its adoption.
